The Fallbrook Vintage Car Club was founded in the mid-1950's and held its first advertised car show in 1965. In 1976, FVCC joined AACA and hosted the AACA Bicentennial Southwest Region Show.

Where is Fallbrook, California?

The location of the National is in Fallbrook, California, about 47 miles north of San Diego Airport. Fallbrook is a hidden gem that is famous for being the avocado capital of the world. The average daytime high in November is 73.8 degrees and the average precipitation for November is about 1 inch.
